CONDITIONS OF SUPPLY:

Unless otherwise agreed in writing, the standard terms of trade are:

1. Payment in full is required by the 20th day of the month following date of invoice and the customer will ensure that their account shall be maintained at a current status at all times otherwise stop credit and gas bottle collection will be enforced 7 days past the due date of any monies owing followed by debt collection proceedings. Debt collection costs will be at the expense of the customer.
2. LPG cannot be purchased from any organization in competition to KIWIGAS and filled into any KIWIGAS gas bottle sized 12KG or heavier.
3. If there is an exclusive supply term agreed upon then the terms of this must be complied.
4. Any shortfalls or defective goods must be reported within 48 hours of delivery.
5. Where the purchase price is not paid in full on the due date, the Supplier reserves the right to charge interest on the outstanding balance at a rate of 5% interest per month.
6. Ownership in any and all goods invoiced shall not pass until the goods are paid for in full.
7. If the goods have been sold or otherwise disposed of by the Buyer, then the proceeds of such resale shall be the property of the Supplier and the Buyer shall be accountable to the Supplier for such proceeds until the purchase price has been paid in full.
8. Gas bottles may be removed without notice if your account is not kept up to a current status.
9. LP gas cylinders supplied remain the ownership of the supplier at all times and the client agrees to pay the monthly cylinder rental relevant to cylinder size.
10. I/We authorise Kiwigas to collect any information that it may require for its credit enquiries from any person relating to credit assessment and/or debt collecting and I/we consent to any person providing Kiwigas with such information. I/we confirm that I/we am/are authorised to give this authorisation.

SUPPLY AGREEMENT

I _____, agree to KIWIGAS being the exclusive supplier of my LPG for the time I have Kiwigas's gas bottles on my premises. I fully acknowledge condition 2 above directly relating to the exclusive supply arrangement as well as the standard terms of trade. I will be paying \$48.00 P.A for gas bottle rental which is to be paid annually with the first payment for rental required with my first supply of LPG. The first year of gas bottle rental is non refundable however after 12 months gas bottle rental, a credit will be given back relating to the months not used over a 12 month period.

Note This is not a fixed contract, it is simply an agreement between both parties that no other company will be used to fill the bottles owned by KIWIGAS. If your situation for gas supply with us changes (for example; you are moving out) then you are simply required to let us know and arrange for the return of the gas bottles.
